Basic Layout of the class (subject to change)

Exams: There are 17 chapters to which I have broken down into 4 units. This will mean there will be 4 exams. If you look above, you will see how they chapters will be grouped together.

Review Papers: There will be 2 review papers that will need to be done. There will be journal articles provided in addition to a writing prompt. There are four possible topics that a student can write about:

- Nature vs. Nurture
- Egocentrism
- Parenting Styles
- Resilience

The first paper must be turned in by **March 17th** and the second paper will need to be turned in by **May 12th**. You could get both done prior to those dates. The topics are on the website.

Project/Presentation/Lab Report: Due to the course content, a main focus will be dedicated to observational research. It will be up to the group to decide what topic to pursue during the course of the class. There will be time in class dedicated to conceptualizing the project, making observations/gathering data, etc., and formulating the lab report. The final for this class will be a presentation over the material. This will be done in groups and will be due on May 11th.
